The living accommodation which is arranged over two levels comprises; entrance porch leading to a utility cupboard, entrance hall, lounge, dining room and a brand new fitted kitchen with built in electric oven and four ring hob on the ground floor. On the first floor the landing leads to two double bedrooms and a modern family bathroom with mixer tap and rain head shower and a separate w.c.

Externally there are well maintained front and rear gardens and a car park to the front of the property. The property also benefits from PVCu double glazing and gas central heating and is being offered to the market with no onward chain. ## LEIGHAM



## PLYMOUTH


