
Properties can be let if they have an energy rating from A to E.

# **Energy rating and score**

# How this affects your energy bills

3. Add additional 80 mm jacket to hot water cylinder	£15 - £30	£22
4. Hot water cylinder thermostat	£200 - £400	£135
5. Solar water heating	£4,000 - £6,000	£106
6. Solar photovoltaic panels	£3,500 - £5,500	£488
7. Wind turbine	£15,000 - £25,000	£934
